- As described in the issuer's registration statement on Form S-1 (File No. 333-239421) under the heading "Description of Securities--Founder Shares," the Class B ordinary shares, par value \$0.0001 per share, of the issuer will automatically convert into Class A ordinary shares, par value \$0.0001 per share, of the issuer at the time of the issuer's initial business combination, or earlier at the option of the holder, on a one-for-one basis, subject to certain adjustment, and have no expiration date.
- The Class B ordinary shares beneficially owned by the reporting person include up to 2,362,500 shares that are subject to forfeiture to the extent the underwriters of the initial public offering of the issuer's securities do not exercise in full their over-allotment option as described in the issuer's registration statement.
- Mr. Sim is the managing member of Aecus Partners LLC. Aecus Partners LLC and WCBRP LLC are the founding member of Artius Acquisition Partners LLC and together exercise voting and investment power with respect to the Class B ordinary shares held by Artius Acquisition Partners LLC. The shares beneficially owned by Artius Acquisition Partners LLC may also be deemed to be beneficially owned by Mr. Sim.
